NOTE:* Türkiye Visa Service Fee amounts must be deposited to the Company account numbered "20202972180800006700" at the "SPITAMEN BANK" branch opened in the name of our company named "AGENTİİ BAYNALMİLALİİ SAYOHI" before arriving at our visa center. Payment must be made in Tajikistan somoni calculated at the effective dollar selling exchange rate of the central bank of the Republic of Tajikistan. You can make your payment at any branch or service point of "SPITAMEN BANK".

*Transfer costs belong to the applicant.

* An explanation such as "For Türkiye Visa Service Fee" must be written on the payment receipt.

* All taxes are included in Türkiye Visa Service Fee fees.

*Turkish visa service fee and consular fee are not refundable under any circumstances.

*** Consular Fees must be delivered to our Visa Center in cash in US Dollars to be forwarded to the Consulate General Branch of the Dushanbe Embassy of the Ministry of Foreign Affairs of the Republic of Turkey on behalf of the applicant.**

Important Considerations:

1. It is recommended that you submit your visa application at least 1 month before your planned travel date. According to the relevant legislation, visa applications must be finalized within a maximum of 90 days. In practice, applications are usually finalized in shorter periods.
2. According to international practice, the issuance of a visa does not mean that a foreigner can certainly enter the country where he/she has obtained the visa. Permission to enter the country is granted by the relevant officials upon arrival.
3. The Consulate visa fee can only be paid in cash in US Dollars.
4. The Consulate visa fee paid is non-refundable under any circumstances, even if your visa application is rejected.
5. All visa types allow a maximum stay of 90 days. No visa type allows you to stay in Türkiye for more than 90 days in the last 180 days. In order to stay in Türkiye more than 90 days, you need to obtain a residence permit from the relevant authorities in Türkiye.
6. For all visa applications, your passport must be valid for at least "60 days + duration of your stay in Türkiye". In addition, your passport must have at least 2 blank pages.
7. For visa applications of children under the age of 18 coming to Türkiye for any purpose, the consent of both parents must be obtained. In order to issue a visa, a custody document or other relevant documents must be submitted in visa application for those whose parents are separated or who declare that one of them is not alive. Persons under 18 years of age cannot apply for a visa directly. One of the parents or another foreigner to whom the parent has given a power of attorney / consent officially in a notary can apply for a visa for a foreigner under the age of 18.
8. A person who arrives at the border gates in order to enter or transit through Türkiye, but is not allowed to enter or transit through Türkiye because he/she does not meet the conditions required by the legislation is considered as an inadmissible passenger (INAD).
9. A deportation order is taken against a foreigner who does not have the right to stay in Türkiye in order to remove him/her from the country. (Please pay attention to the duration and rules of your stay in Türkiye in order to avoid the deportation order).
10. A visa does not provide the right to work. If you wish to work in Türkiye, you must obtain a work visa from the diplomatic representative offices of the Republic of Türkiye in your country of citizenship or legal residence.
11. The visa for tourism purposes is valid only for tourist trips.
12. In principle, the visa application must be made in person. It is not possible for a foreigner over 18 years of age to apply for a visa on behalf of someone else.
13. Foreigners with a valid residence permit or work permit on the date of entry into Türkiye may enter Türkiye without a visa.

14. The visa applications for education, training and work purposes and visa applications of persons who are prohibited to enter to Türkiye take longer than other applications. Please pay attention to this issue when making your application.
15. It is not possible to pay the fines for violating visa, residence or work rules of Türkiye to our Embassy. You can only pay these fines at the payment points in the airports.
16. Phone inquiries will be answered only between 9:00-10:00 and 16.00-17.00 on weekdays. Outside of these hours, Consular agents will not be accessible by phone. For any queries, feel free to reach out to us via email or our social media accounts 24/7. Email : embassy.dushanbe@mfa.gov.tr

17. Please be informed that approved visas are available for collection by applicants at the Embassy between 16.00-17.00 hours on weekdays only.

Visa application process:

- 1. For all visa applications, you must first obtain information about the required documents on the website of our ABC visa center.**
- 2. The documents required for visa application are classified according to visa types and are stated on the website of our visa center.**
- 3. You must apply directly to our Embassy visa center with your ready visa documents, without making an appointment. When your visa application is finalized, you will be informed via the communication method you deem appropriate.**
- 4. You must present your original passport when you apply. However, after applying, you can get your passport back until your visa application is finalized. If your visa application is successful, you must come to our Visa center with your passport to get your visa.**
- 5. The documents you submit for your visa application belong to the Embassy and cannot be returned to you.**

Visa types and required documents:

Tourist Visa:

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. (If available) Notarized Invitation Letter from Turkey or Invitation letter from the exporting company (this document is not required in tourism) or Tour package information letter from the Visiting tourism company
6. Hotel reservation
7. Round-trip flight ticket reservation
8. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
9. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Business/Commercial/Trade visa:

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. Invitation Letter to be received from the company in Turkey, stating the purpose, duration and place of stay of the visit and promising that the expenses will be covered by the company.
6. Document and employment contract containing the company's activity information regarding the applicant's line of business.
7. Document proving the applicant's position in the company.
8. Invitation from the company or an official to attend meetings, conferences or events related to trade, industry or business. Entrance tickets to fairs and congresses, where applicable.
9. Documents proving the existence of commercial or business relationships (Agreements, invoices, order lists, etc.)
10. Documents confirming the business activities of the company (Annual accounts, trade register, annual report, etc.)
11. Round-trip flight ticket reservation
12. Hotel reservation
13. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
14. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Student Visa (for High School, Secondary Education, Primary Education):

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. Student certificate and Acceptance letter.
6. Graduation certificate and transcript from the last educational institution.
7. Payment receipt if payment has been made to the educational institution.
8. Notarized consent of the parents (if under 18 years of age) (document proving this if one of the parents is not alive or if one parent has custody)
9. One way flight ticket reservation
10. Hotel/dormitory reservation or document about places to stay.
11. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
12. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Education Visa (for University, Master's and doctoral studies)

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. Student certificate and Acceptance letter.
6. Graduation certificate and transcript from the last educational institution.
7. Payment receipt if payment has been made to the educational institution.
8. Notarized consent of the parents (if under 18 years of age) (document proving this if one of the parents is not alive or if one parent has custody)
9. One way flight ticket reservation
10. Hotel/dormitory reservation or document about places to stay.
11. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
12. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Work visa:

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Employer invitation to our representative office
5. Employment Contract (signed by those concerned)
6. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
7. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Transport Visa:

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. The original of the letter sent by the transportation company.
5. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
6. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Event Participation Visa (Conference, seminar, sporting activity, etc.):

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. The original of the invitation letter issued by the event in which participation is planned (the invitation letter should include information such as the information of the inviting institution, the identity information of the invited person, the purpose of the invitation, the dates and location of the event, who will cover the expenses during the event, etc.)
6. Hotel reservation
7. Round-trip flight ticket reservation
8. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
9. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Turkish Language Course Visa:

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. Certificate of acceptance to the Language Course.
6. Graduation certificate and transcript from the last educational institution.
7. Payment receipt if payment has been made to the educational institution.
8. Notarized consent of the parents (if under 18 years of age) (document proving this if one of the parents is not alive or if one parent has custody)
9. One way flight ticket reservation
10. Hotel/dormitory reservation or document about places to stay.
11. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
12. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Treatment Visa:

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. In addition to the official document issued by the medical institution in Turkey stating that the specified medical treatment can be performed and that the patient will be accepted for this treatment, an official document showing the approximate duration and cost of the treatment.
6. Official document obtained from the health institutions in the country where the foreigner is located.
7. If available other correspondence, between the doctor referring the patient and the receiving hospital.
8. If available, documents and reports, indicating that the foreigner received treatment in a third country for the same disease.
9. Hotel reservation
10. Round-trip flight ticket reservation
11. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
12. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Visa for accompanying patient:

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. A document proving the relationship with the patient (kinship, etc.) or a written statement on the patient admission document that he or she is a companion.
6. (In cases where the patient cannot apply for a visa) In addition to the official document issued by the medical institution in Turkey stating that the specified medical treatment can be performed and that the patient will be accepted for this treatment, an official document showing the approximate duration and cost of the treatment; official document received from the health institutions in the country where the foreigner is located; if available other correspondence, between the doctor referring the patient and the receiving hospital; if available, documents and reports, indicating that the foreigner received treatment in a third country for the same disease.
7. Hotel reservation
8. Round-trip flight ticket reservation
10. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
11. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Transit Visa:

(Tajik citizens do not have to obtain a visa while transiting through Turkey. However, if they are going to transit by entering Turkey, they are required to obtain a visa.)

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. Visa and residence permit requested by the country to be transited from Turkey.
6. Round-trip flight ticket from Turkey to the destination country.
7. Round-trip flight ticket reservation
8. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
9. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

Family reunification visa:

1. Valid passport and its photocopy
2. One biometric photograph, 5x5cm, with a white background.
3. Criminal record document (if you are not a Tajik citizen and reside in Tajikistan, you must submit the criminal record document obtained from both the country of your citizenship and the Tajik authorities.)
4. Bank statement or financial status certificate.
5. Any document proving the relationship with a first-degree relative (mother, father, spouse, child) who is a Turkish citizen (international family certificate, birth certificate copy, etc.)
6. Hotel reservation
7. Round-trip flight ticket reservation
8. Visa service fee payment receipt and Consular fee in cash (60 USD for a single entry visa, 190 USD for multiple entry visas.)
9. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support your purpose of visit, prove that you will leave Turkey at the end of your visa period, and show your socio-economic situation.

For other visa types (Scientific research, Archaeological excavation / research, Press, Film or documentary shooting, etc.), please get information from our Embassy's visa center.
